**Item No.3: Any other issue with their permission of the Chair.**

**i) In the matter of non-submission of fees proposal in the AY 2019-20 by Sai Homoeopathic Medical College and Nityanand Hospital, Thane.**

Read communication dated 20/3/2019. The college did not submit fees proposal for AY2019-20 within time prescribed. Extension was sought vide communication dated 5/12/2018. Time to submit fees proposal was extended till 29/12/2018. The college did not submit the fees proposal. Again request is made to grant further time. There is no justification for extending the time to submit fees proposal which was over on 31/10/2018.

Approved fee structure for AY 2017-18 was Rs. 67,000/- . The college did not opt for upward revision of the fees for AY 2018-19. On account of failure of the college to submit fees proposal within time and even within time extended by this Authority, previous academic year's fees shall apply. Having regard to the fee structure approved by this Authority for the AY 2017-18, it being Rs. 67,000/-, and there being no upward revision in the AY 2018-19, the fee structure for the AY 2019-20 shall be Rs. 70,000/- This shall be subject to the college submitting Balance sheet of financial 2017-18 year, Auditors report and details of non-salary expenditure, sanctioned strength and actual strength of the students.



ii) **This relates to fixation of fees of RANM course for AY 2016-17 & 2017-18 conducted by Bhartiya Mahila Vikas Nursing School, Wardha.**

For AY 2015-16 this Authority has approved Rs. 63,000/- being the fee structure for RANM course. The institute did not submit fees proposal for AY 2016-17 & 2017-18. Therefore fees as approved for AY 2015-16 was collected from the students in 2016-17 batch. Vide communication dated 17/3/2019 the institute has requested to approve fees structure for AY 2017-18.

Non submission of fees proposal for AY 2017-18 is deliberate failure on the part of the institute. By analogy, even for AY 2017-18, fees structure for previous AY shall apply. Accordingly the fee structure for AY 2017-18 shall be Rs. 63,000/-. The college shall submit a declaration on oath as to what amount of fees they have collected from the students in AY 2017-18 batch. They should also clarify amount of reimbursement claimed from the concerned department relating to the students in 2017-18 batch. The names & addresses of the student in 2017-18 batch shall also be submitted.
