4. The program has been granted accreditation for further 3 years. **Karmaveer Kakasaheb Wagh Education Society's K.K. Wagh Institute of Engineering Education and Research, Hirabai Haridas Vidyanagari, Amrutdham Panchavati, Nashik, Maharashtra – 422003** should submit fresh online application under SAR Tier-II June 2015 Document through eNBA portal at least five months before the expiry of validity of accreditation mentioned above.

5. The accreditation status awarded to the program as indicated in the above table does not imply that the accreditation has been granted to **Karmaveer Kakasaheb Wagh Education Society's K.K.
